CHEER takes a holistic approach to addressing the most important social determinants of health, such as access to healthy food and medical care, youth development, community activities, and housing and community development.**

**Healthy Long Branch: This program employs community members as community health workers and outreach specialists to promote health and access to health care. In FY 2020, CHEER made 1,469 health and wellness service contacts to people in Long Branch and Takoma Park. The Long Branch Healthy Food Access program provides weekly delivery of fresh produce and the support of a community health worker to people with diabetes and low access to healthy food. In FY 2020 85 program participants received 1,189 boxes of fresh produce. produce and more than 60% of them improved their blood glucose control, lost weight, and improved their self-reported health status. CHEER application counselors enrolled 289 households (924 people) in Qualified Health Plans or Medicaid through the Maryland Health Benefit Exchange. At the end of FY 2020, during the covid-19 pandemic, the health team also helped residents enroll in SNAP and apply for rent relief.**

**Summer Youth Enrichment Program: Lunch and Learn**  
**The 2019 Lunch and Learn summer youth program was held at Takoma Park Elementary School for six weeks in the summer of 2019. The camp enrolled 198 school aged students at no cost to children who had few or no other summer program opportunities. All children received free breakfast and lunch and participated in play and sports activities. 111 elementary school students also participated in math and reading classes and swimming lessons. Among the students taking both pre and post tests, 84% scored equal or higher at the end of the camp for reading and 83% for Math.**  
**Middle and high school students engaged in social and educational enrichment and service learning. All these students also participated in some student service learning (SSL) activities. These 67 youth performed 1,634 hours of service on a variety of projects.**

**Empowerment and Leadership Development**  
**This program supports community groups in under served and under represented neighborhoods to organize community events and activities and support their participation in civic affairs and public decision making. In FY 2020 this program supported 29 members of two community groups. One, Conexo, is a group of 14 mostly Spanish speaking community leaders in the New Hampshire Estates Neighborhood in Silver Spring. The second, Maple Tree Group, has 15 members who are mostly African immigrants and Amharic speakers. Conexo members had sessions for learning technology and on empowerment. They helped organize for a neighborhood block party, and planned for a neighborhood cleanup event until covid-19 shut it down. The Maple Tree Group conducted a community wide picnic that drew 85 participants, started a fitness class, and initiated an English conversation class.**  
**After the covid-19 shut down began, both these groups participated in CHEER's community-wide food distributions. In June these groups distributed 501 boxes of fresh produce to 185 families, 314 at New Hampshire Estates and 187 at Maple Avenue.**
